

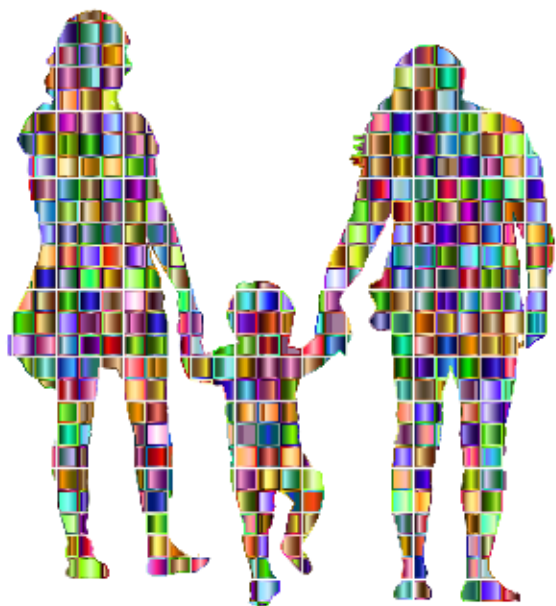

Unity Family Services work through an in-home, team-delivered approach to enable parents/guardians to care for their children and adolescents experiencing significant mental health or behavioral concerns at home and help to reduce the need for more restrictive out-of-home placements.



Our mission is to support families to remain together in the home. We believe that in-home treatment can allow therapists a unique view of the family and allows therapists to better meet the unique needs of each family. We aim to strengthen and maintain the family and help members to improve their ability to manage stressful life situations.

Unity Family Services is committed to following CASSP principles by providing treatment that is child centered, family focused, community based, collaborative with all systems involved with the child, and least restrictive and least intrusive as possible.



Our therapists are trained to support families in dealing with a variety of life situations including blended families, divorced families, grandparents raising grandchildren, trauma, grief and loss, and children and families struggling to manage the symptoms of their psychiatric diagnoses.

All family services will utilize a family systems approach that provides structural family therapy and cognitive behavioral treatments. Further, we offer clinical intervention to fit your family's needs including parent education, social/life skills training, and coping skill building.

We Can Help ...

The program will also assist families through case management, crisis/safety stabilization, 24/7 on call coverage, and linkage to community resources. Therapist teams are available for day, evening, and weekend appointments as needed. Our therapists work to be flexible to your family's needs and schedule.

Unity Family Services seeks to serve families who find that traditional outpatient services are insufficient or ineffective and to establish connections to other services after out services have ended to ensure a continuous, high level of care.

We strive to provide the best mental health care to your child and your family.

We will act as an advocate and will provide consultation and support through collaboration with schools, Intermediate Units, hospitals, residential programs, psychiatrists, and other community agencies to provide coordinated individual and family service plans.

This is a voluntary service, and all in-home services/treatments will speak to the family's understanding of their needs and wishes. This agency's purpose is to assist families in working towards achieving their own goals and objectives.

Unity Family Services focuses on "clinical treatment" not just behavioral interventions. Therefore, the underlying issues and problems are dealt with, not just the symptoms of the problems.
